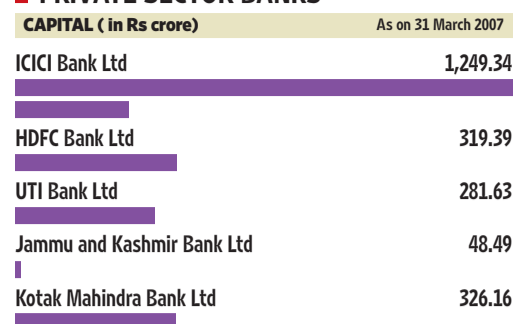


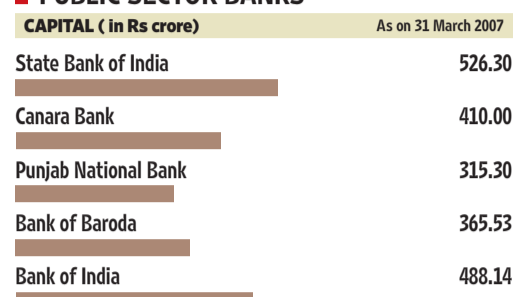
# INDIAN BANKING

Foreign banks account for less than half-a-percent of branch network, about 5% of deposits, 20% of capital and less than 7% of banking assets.

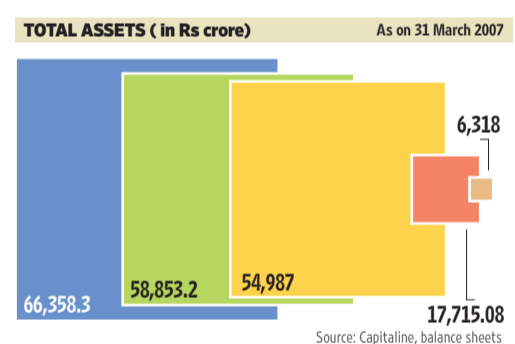
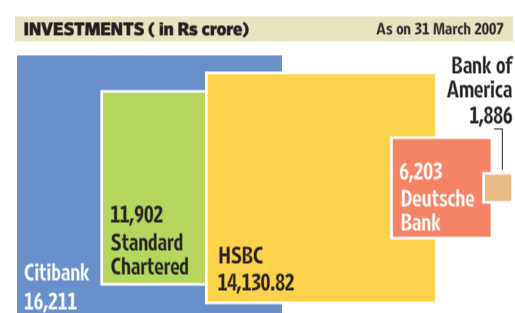
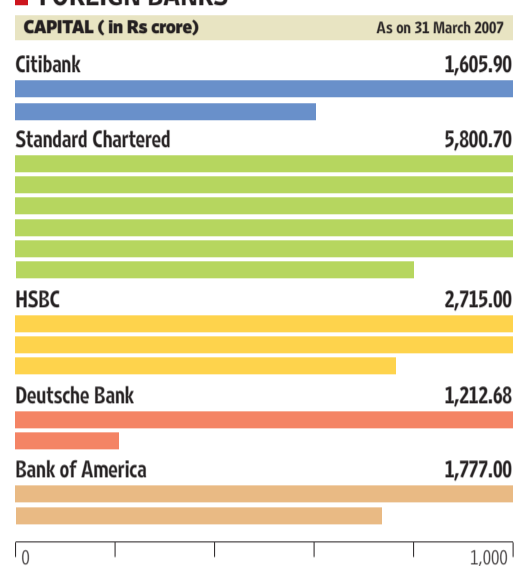
